I was pretty pissed off with my mates because I'd kept asking them to let me focus on driving – then I got flashed. Stung by a £60 fine and three points, I was on edge everywhere I went. Driving just wasn't fun any more!

About a year later I'd pretty much got over the worrying and knew I had only another seven months until my probationary period was over. But August must be my unlucky month, because on

a trip to check out uni halls in Guildford I made a very silly mistake. It was an area I didn't really know and whilst trying to navigate around the city centre, I accidentally went through a red light a few seconds after it had turned red – I was flashed by another camera. My heart sank; I knew instantly what had happened.

Having to start again, I passed the theory test first time. But having picked up so many bad habits it took me ten lessons and two attempts to get through my practical again. If I could give one piece of advice to new drivers, it would be to avoid getting any points at all. Driving knowing that one wrong move could cause you to lose your licence is no fun, and making that wrong move is even less fun!

MHAT IS THE PROBATIONARY PERIOD?

T'S A BIT LIKE when you start a new job and you're put on a six-month 'trial'; your employer is making sure you're not rubbish before committing to let you work permanently, with all the rights and privileges of someone who's been working there for years. It's the same with driving. You're automatically on a two-year probationary period from when you pass your practical test; during those two years you're allowed to clock up six points before your licence is

turned green again. That's right, back to wearing L-plates until you've passed all the tests, just like before.

Once you're out of probation it'll take 12 points before you lose your licence, but for the first two years it's just the six – and they're easier to clock up than vou might think! Remember that once you have your first three points, the next set means GAME OVER. Driving can be stressful enough without having to worry if one silly mistake is going to cost you your licence.

Drive, or even attempt to drive when you're over the limit, and it's an instant 12-month ban that'll stay on your record for 11 years! Yep, insurers won't like that much either.

driving? You're wrong: driving whilst unfit through (even prescription) drugs carries an instant ban for at least 12 months.

Break the speed limit and you'll get between three and six points. If you regularly drive too fast, you could be snapped

twice and not realise until it's too late.



Going through a red light clocks

up three points, and not much gets past red light cameras! Concentrate and leave vourself plenty of space to brake.



MARILE PHANE

If you talk, text or even play with your phone whilst driving, it's a straight three points. CCTV footage can now be used too, so no good just keeping an eye out for the fuzz.

I NGI IRANT F

Driving without insurance scores you 6-8 points: the police may take your car too. It'll cost you £150 to retrieve it plus £20 per day storage. Alternatively they'll crush it for you.

Drive like an idiot and you can expect to be walking soon. Get caught and the enormous fine will be the least of your worries, as this offence carries 3-9 points.

ISI WI VIL FIFF

If you're in a smash (or even a bump), make sure you stop and exchange details, otherwise it's anywhere between three and nine points. See accident checklist opposite.

If you leave your car in a dangerous position it could be towed away - and you'll be given three points for the inconvenience you've caused.

FIRGT.

If a car involved has failed to stop, take their registration or a description (make, model, colour) as quickly as possible. Call the police if there's debris on the road or an obstruction to traffic - or if any other driver is aggressive or uncooperative.






